What to expect:

All **Wills Day** participants receive two one-on-one private meetings with an experienced estate planning attorney, held on-site at **Duke Credit Union**.

Meeting #1

30 minute estate planning session, followed-up by Meeting #2 a few weeks later.

Meeting #2

15 minute session where final documents are reviewed and signed.

While couples (spouses and companions) are encouraged to attend all meetings together, both parties are only required to attend Meeting #2 for final signatures of the estate planning documents.

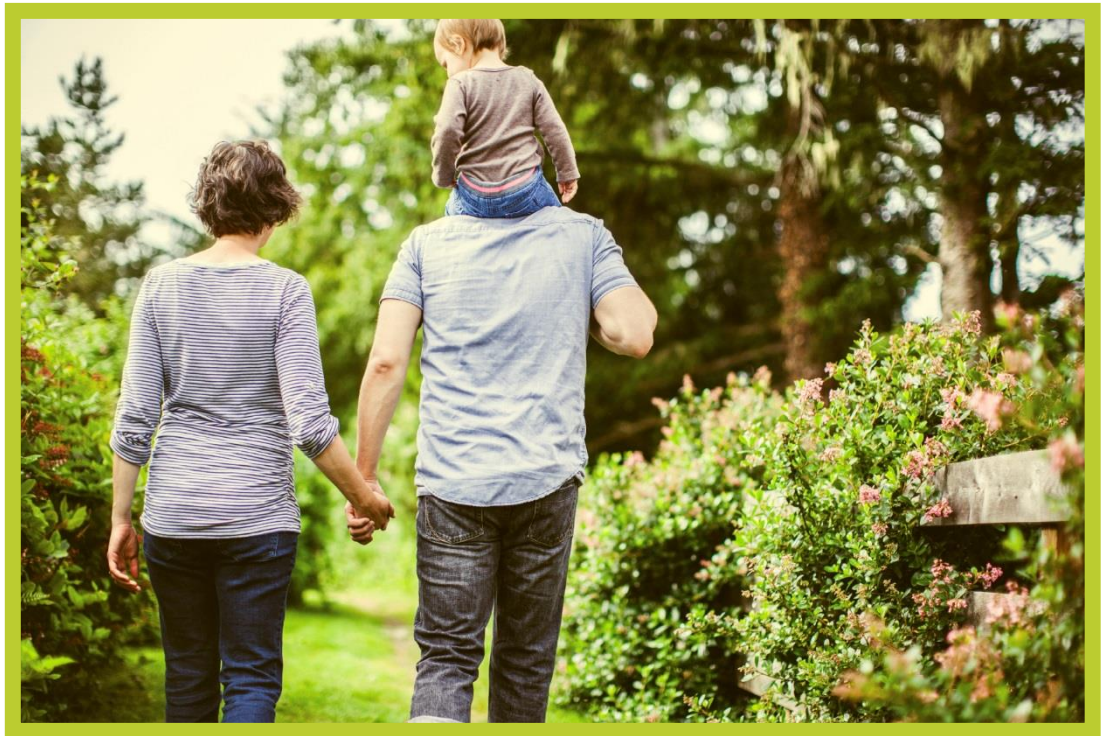
Payment & Fees
