## What to expect:

All **Wills Day** participants will receive two private meetings with an experienced estate planning attorney, held on-site at **Duke Credit Union**.

### First Meeting\*

**45-minute** estate planning session, followed-up by a second meeting a few weeks later.

### Second Meeting

**20-minute** session where final documents are reviewed and signed.

While couples (spouses or unrelated domestic companions) are encouraged to attend all meetings together, both parties are only required to attend the second 20-minute meeting for final signatures of the estate.
